## Board Briefs for March

At its March 15 meeting, the Board:

■ Heard that our letter supporting availability of condoms at high school health centers was well received by the Board of Education, and they voted in favor;

■ Heard that the Planning Board has been unresponsive to our requests for a public meeting on Measure A;

■ Considered a request for ideas for the OneCareNow (single payer health care) event we have been told to hold on May 13;

■ Heard a report on preparations for Meet Your Public Officials;

■ Heard that our orientation event for new members went well, that five new members attended, and that one has already offered to take an active part, working on a program to encourage younger students to start planning for college;

■ Agreed to hold a forum on proposed state health care legislation in May; and

■ Voted to reimburse delegates the state convention.

## Ranked Choice Voting topic at Commonwealth Club April 19

Now that some evidence suggests that ranked choice voting increases voter turnout and controls costs at the local level, is it time to consider applying it to statewide elections?

In 2004, San Francisco voters started using Ranked Choice Voting (RCV) in city and county elections. In addition to assuring that winning candidates are elected with over 50 percent of the vote, the new voting technique has increased voter turnout and eliminated the need for - and expense of - run-off elections. Now, Alameda and Santa Clara counties are developing RCV systems for their 2008 elections.

As these Bay Area counties lead the way in changing how their citizens vote, what are the implications for adoption of this voting method statewide? Additionally, what steps would ease the process of implementing RCV for other jurisdictions?

# Single Payer Health Care Insurance Plan (SB 840) – Update

With its re-introduction to the California legislature Feb. 23, by Sen. Sheila Kuehl, following its veto by Gov. Arnold Schwarzenegger last September, the process of bringing single payer health care insurance to every California resident begins once again.

The new SB 840 has been designated as the "California Universal Healthcare Act." (The previous bill was designated as the "California Health Insurance Reliability Act.") A review of the bill thus far has revealed no other significant

changes.

In addition to the re-introduction of SB 840, Gov. Schwarzenegger has proposed a health care insurance plan which has not yet moved into the legislative process as a bill; and both Sen. Don Perata and Assembly Member Fabian Nunez have introduced their own bills: SB 48 and AB 8, respectively.

Under Sen. Kuehl's proposal, Californians would choose their own doctors and other health care providers. A California Health Insurance Agency would take the

place of the current myriad of health insurance companies.

The increased efficiency would save enough of the monies now spent on health care to provide affordable and secure comprehensive health care for all residents. Since health coverage would no longer be linked to employment, conflicts between workers and employers over this issue would no longer exist, nor would gaps due to changing jobs.

Passing this legislation is a priority of LWV California.

## Linking land use and water in the Bay Area April 23

Join local officials and water and land use professionals April 23 for a daylong workshop about integrating water and land use: "A Workshop of the Local Government Commission and the Bay Area Water Forum."

How and where we grow has a direct impact on the quality and reliability of water in California. Growing communities face major challenges with stormwater runoff, flood liability, and concerns about if there will be reliable water for current residents and for new development.

### ■ Who should attend:

Local elected officials and staff, Land use planners, Public

works engineers, Watershed coordinators and members, Water management professionals, Developers and designers, State government officials and agency staff, Interested community members.

Sessions will discuss strategies, explore case studies, and engage participants in dialogue about ways to coordinate land use and water management.

- Water and Land Use - What's the Connection?
- Weighing Costs, Benefits, Carrots, and Sticks
- Planning for Water-Wise Growth

■ Sustainable Site Design Strategies (LID)

■ Policy Solutions - The Water Element

The workshop will be in Oakland (a confirmation letter and directions to the finalized location will be faxed or e-mailed a week prior to the event).

The League of Women Voters of Alameda would like to thank President Patrick Lynch and members of the Planning Board for their action in forming a sub-committee to plan educational meetings on Measure A. Measure A is an issue that is vital to every person in Alameda — decisions we make today will impact our future quality of life. Public meetings are part of community engagement and offer an opportunity to understand the citywide impacts of Measure A on land-use planning, housing types, social equity, and transportation. In these meetings, citizens will have an opportunity to learn and comment on

their vision for Alameda in ways that preserve the characteristics of Alameda we all value. In following the Measure A discussions we have heard repeated comments regarding the limitations it imposes on planning excellence. It is sensible to weigh these impacts in open forums. Despite statements to the contrary, the League does not support or oppose possible exemptions to Measure A and does not believe that discussing Measure A is taking a position to retain, amend or discard it. Open, civil discussions of matters affecting civic policy are part of good government, and we thank the Planning Board for their actions.

## Convention Business

Convention delegates meet to determine the direction of the League of Women Voters of California for the next two years. Adoption of program for the next two years is an important item of business.

## Workshops

Workshops Friday and Saturday provide educational opportunities for all who register, even non-voting delegates. A two-part track will focus on the California state budget: Part I will be a presentation by Next Ten on the budget and how we fund infrastructure; Part II--Follow the Money--will provide information on how to track spending in your own community.

## Other Activities

Thursday afternoon, May 17, we have special activities. The LWVC will hold a Homeowner Association Election Training to discuss the origins and details of the law requiring homeowners to hold elections in a prescribed manner. There will be an opportunity to explore pitfalls to watch out for. Hopefully, we will also have some testimonials from local Leagues that have already acted in this capacity.

Also, a visit to the Kern County Water Agency and the Smart Voter team invites everyone to a pre-convention dinner.

## LWVC Education Fund receives \$400,000

We had great news March 13. The Irvine Foundation informed us that they have awarded the LWVCEF a \$400,000 grant.

The money will help underwrite capacity building activities for the Education Fund and partially underwrite Easy Voter Guide expenses for two statewide elections in 2008. Fundraising activities are continuing due to the fact that there will now be an additional presidential primary Feb. 5, 2008.

In the past the Secretary of State's office has provided extensive support

(both financial and logistical) for the Easy Voter Guide. Meetings with them to discuss plans to meet the new challenge of a third election in the 2008 cycle have already begun.

Also, as soon as possible, we hope to hire a communications staff person as part of our capacity building activities. That person will assist us in getting our messages out to voters across the state. We are grateful to the Irvine Foundation for their confidence in our work to involve more Californians in the democratic process.

### Story from Karen Mitchell, LWV Spartanburg County, SC

Women who know about voting and what is going on in the world, that's neat, I thought. I was a child of 11 when I read about it in the local paper. Twenty years later I found myself in a new section of our country and in a small town. And there it was, a small piece in the newspaper saying that a League of Women Voters chapter was being formed. That's me, I thought, and it was me. The small town grew and the League helped me to grow in knowledge and leadership. And then there it was looming right over us--a huge problem no one would admit was a problem. Twenty-five-percent of the people of the town lived in housing projects and the residents were getting no action to help them create better lives. It was not good for the residents and not good for the town.

The League of Women Voters took action. I tried to attend public meetings, but they were held in the office of the Executive Director. There was little or no notice. I found my way into the office to sit in a corner chair and listen. We researched other towns and their housing communities. We had a public meeting. We got facts to the newspaper. They pursued the story. Shortly thereafter everything changed - new director, new Board, and new ideas that helped the residents. Now they began to be housing communities, not housing projects.

Today this town has been the recipient of two federal multi-million dollar HOPE Grants that have changed the way residents of housing communities live their lives. We think the League of Women Voters had a significant part in creating better lives for 25% of our community and therefore all of us too.

### Tips on writing your story

- Keep writing style simple and as easy to read as possible
- Use short words and sentences (not more than 25 words)
- Write short paragraphs (not more than 60 words)
- Use the active voice and a conversational style
- Avoid slang and colloquialisms
- Sequence main points in a logical manner
- Make your sub-points clearly respond to the main point

## A manual on water privatization

When the city of Stockton failed to conduct an environmental impact report prior to approving a contract to privatize the municipal water utility's operations and management, the LWV of San Joaquin County became a coplaintiff in a lawsuit challenging the city and OMI Thames, a water conglomerate. Portions of the lawsuit have been upheld, though it's still an ongoing pro-

cess and portions may be appealed.
