## **The League Seeks Consensus on The National Popular Vote**

Grassroots agreement on positions is one of the League's greatest strengths. Preparing for and taking consensus is hard work, but worthwhile. The resulting position will allow the organization to educate the public and affect national policy for years to come, just as we have been doing in other areas for 88 years – it is part of the organization's history.

At the 2008 Convention, the delegates voted to adopt a new study, "The Advisability of Using the National Popular Vote Compact among the States as a Method for Electing the President." This year each local League is asked to come to a consensus on this issue.

In February, we will be holding some meetings to consider the questions. Our deadline for submitting our consensus is early March. ### **Background for the National Popular Vote Compact**

The League has a long-standing position in support of the direct election of the president by popular vote. Now, League members have the opportunity to consider whether to support the National Popular Vote Compact (NPV Compact) as a viable process to achieve that result. The NPV Compact would avoid the need for a constitutional amendment abolishing the Electoral College (EC), and would assure that the individual receiving the most votes would become president.

The NPV Compact proposal uses the mechanism of the EC. States that legislatively enact the NPV Compact would agree that their state electors would vote for the individual that received the most votes nationwide. Thus, the popular vote count from all 50 states and the District of Columbia would be added together. State elections officials in all states participating would award their electoral votes to the presidential candidate who receives the largest number of popular votes.

This alternative method of assigning a state's EC votes would take effect only when enacted by states collectively possessing a majority of the electoral votes. This 270-vote threshold also corresponds essentially to states representing a majority of the people of the United States.

The plan includes procedural provisions to help assure smooth functioning of the agreement – conditions that deal with states deciding to withdraw from the Compact at the last moment, enforcement issues and recounts.

Speaking of volunteering, our new President, Barack Obama has asked all of us to contribute to our communities. Starbucks is asking people to sign up to do five hours of work. ## News on Prop 11!

The passage of Proposition 11, the California Voters First initiative, last November marked a turning point regarding state legislative elections. No longer will legislators design the voting districts following each census with the goal of incumbent protection; instead an Independent Citizens Commission will draw the boundaries with the goal of seeing that cities, counties, and communities of interest within them have a voice in Sacramento. The League, believing in representative democracy, was a major supporter of the measure.

Court challenges follow the passage of many controversial propositions, as opponents seek to undo voters' decisions. None has been forthcoming regarding Prop 11 in spite of the fact the Democratic Party officially opposed it. The reason would seem to be that the leader of the opposition, former Senate President pro-tem Don Perata, has other matters on his mind. As the San Francisco Chronicle reports, he has taken the majority of the money contributed at his behest by the Prison Guards Union to the Prop 11 opposition campaign and transferred it to his legal defense fund. Thus far no anti-Prop 11 litigation has been initiated.

Instead implementation of the redistricting reform measure is underway.

The State Auditor, in charge of selecting the individuals who will serve on the Independent Citizens Redistricting Commission, has expressed her commitment to making the selection-recruitment process as open and broad as possible. A series of five meetings has been scheduled up and down the state in January and February to "solicit comments about the processes that should be established for individuals to apply to become members of the Commission and for the selection of an Applicant Review Panel to assess the applicants and create an applicant pool of 60 qualified members."

The San Francisco meeting will be held on Friday, February 27 at 455 Golden Gate Avenue.

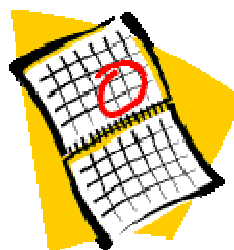
