The League, as it always does, did a fine job of voter education for the one-item February election. Thanks to the stalwart team of Karen Butter, Joanne McKray, Juelle Ann Boyer, Sally Faulhaber, Li Volin, Jeff Cambra, Anne Spanier, and others, we spent the very short time we had over the holidays and in January getting questions for the proponents and opponents prepared and answered. We disseminated the material in binders at the libraries and at the Mastick Senior Center, had it published in the local papers, videoed it and got it up on the web and as a link from our web site, Smartvoter.org and some of the local blogs. Not to mention the forum we held, which was so well attended we had to ask some of the people crowding the room to wait outside so that the fire marshal didn't shut down the meeting!

The Alameda Point Initiative was indeed an emotional subject, and a lot of pressure was put on the League to join the "con" side with a position against it. Some of this came from the community and some from our own members. In another place in this issue of the VOTER there is an article that explains how the League arrives at a decision to support or oppose a measure on the ballot and how our non-partisan stance should not be confused with the possibility that we might also advocate for or against a matter which we have studied and arrived at consensus. The League only speaks from its established positions, be those established through national, state or local studies and consensus. In the case of the Alameda Point Initiative, our existing positions did not cover the many aspects of the measure, so we remained neutral and did the extensive educational effort.

It is nominating season, and once again we are asking League members to step up to the plate and take on leadership positions. Yes, it is work, and yes, it is going to take some of your precious time, but also, yes, it will mean that you have the opportunity to make a significant contribution to the betterment of our community and its government. So please consider saying "yes" when you get that call. We have posted all the Board job descriptions on the League web page, and feel free to contact any of us on the current board to ask what it means to be a League leader. Frankly, having served as president and co-president several times, I feel very proud of our board. It is a highly functional body with very little in the way of contention and a good deal of mutual respect and helpfulness among its members. While discussions may be vigorous and opinions strongly stated at times, there is also humor, friendship and camaraderie. If you feel that you just couldn't possibly volunteer for something you might not be adequate to undertake, just remember, all of us were new to League leadership at one time and found our way, with the trust and help of the more seasoned leaders.

As we approach the next election cycle – June is not so far away, please consider how you can help to insure good voter education by volunteering. And after June, there will be November, when we will have many municipal candidates as well as a plethora of ballot measures! Our work never ends, as long as there are elections and issues and voters to be educated.

Free Movie a Success

The celebration of the league's 90th Birthday held at the little theater of the Alameda High School saw almost a dozen young students, including a few young men as well viewing the movie in rapt attention. More than 50 adult women and a few men joined them in viewing what was a well acted made for TV movie about the struggle for the 19th amendment during the years of 1912-1920. The actors included Hilary Swank who played Alice Paul the upstart radical reformer and Angelica Huston playing Carrie Chapman Catt who later founded the League of Women voters. Mrs. Catt resisted the radical approaches of Alice Paul and Lucy Burns until she finally realized that after years of being told to "wait a little longer" President Wilson was not going to sign the amendment. Alice Paul and her cohorts understood this and took to the streets landing in jail, brutalized and force fed after a hunger strike. When news got out about the brutality, President Wilson capitulated and signed the amendment. The drama was quite compelling. Everyone was glued to their seats.

The response was quite enthusiastic. League volunteers were busy handing out extra Voters and envelopes advising all about how to join the League. Volunteers also distributed *the Know Your Representative* to audience members. Many women commented favorably about the information and it is hoped that we sparked a membership interest in a group of people who appeared to be our target group.

The best news yet was this message received from an attendee to Robby Kiley:

I wanted to thank you for inviting us to see the Iron Jawed Angels movie about the women's suffrage movement. It was great and very moving. I'm suggesting it to my boss to see at lunch time at my company next month for Women's History month.

The League of Women Voters-Strictly Non-partisan

Ninety years ago, Carrie Chapman Catt first proposed a League of Women Voters to “finish the fight” and work to end all discrimination against women. And so the League of Women Voters was founded on Valentine’s Day in 1920, six months before the ratification of the 19th Amendment giving women the right to vote.

Today we are a grassroots organization with 850 Leagues throughout all 50 states. During the 1970s, the League supported the equal rights amendment, and conducted presidential debates. In addition, the passage of the motor voter act, campaign finance reform and the redistricting act in California were activities that the League members throughout the country, and here locally, worked tirelessly to effect. Although the League is known widely for our voter education efforts, the League of Women Voters has been an institution in Alameda for over 30 years, educating Alamedans through pro and con forums and candidate’s nights, distributing voter education materials, working on education and library issues, and serving as citizen advocates for good government.

The League is strictly non-*partisan*, but we have always been political, advocating to effect change at the national and local level. As we enter into a new year, we don’t know exactly what new issues will confront Alameda. We do know that the League will be there doing what it has been trusted to do for more than 90 years: discuss the important issues, ask the difficult questions and demand accountability from our local government.

Our members join the League because they know that whatever happens to our democracy over the next 90 years, it should be up to us, the people. The League of Women Voters is *the* organization where hands-on work to safeguard democracy leads to civic improvement, and this year, on our 90th Anniversary, we hope you will stand with us in this work. If we don’t do it, who will?

Voter Service Committee Gears up for Coming Elections

The crowded election cycle continues as June 8, the date of the 2010 MID-year primary election, approaches. A lengthy list of congressional, state, and county offices will be contested, as old-timers and newcomers battle to retain or attain their chosen niche. At the federal level Senator Boxer will be challenged, and our Representative Pete Stark probably won't be in any serious fashion. At the state level the contest for Governor will doubtless receive the most attention, and in Alameda, where no local races for offices will be involved, interest as to candidates will probably center on the contest to choose the District 3 representative on the Alameda County Board of Supervisors. The race will involve several Alamedans, the full list to be determined after the March 12 filing deadline.

In addition to evaluating candidates, voters will need to do their homework regarding five state ballot propositions, and perhaps a local school parcel tax measure requiring voters to decide whether to pay more to avoid draconian cuts in AUSD programs. The state propositions include a proposal to change the primary election process, a pilot program to enact public financing for Secretary of State races, a property tax exemption for seismic retrofitting, a two-thirds vote requirement to allow cities to become public electricity providers, and a change in auto insurance pricing.

Enter the Alameda League of Women Voters! One of our major mission is to gather and present information prior to elections to help voters make informed decisions. Presently we're in the process of making plans.

As usual we will be presenting one or more public events where voters can hear local candidates - this time for a county office - speak, and pros and cons regarding ballot measures. This will happen in early May, as the absentee ballots go out. About that time we will be delivering Easy Voter Guides and other materials to over 30 different sites for distribution. (If you know of a location which would appreciate having such materials, please let us know!) Jeff Cambra, who for the last two elections has been producing videos recording events and presenting additional information about issues for our local League, will be at it again, this time filming presentations by candidates in addition to those about ballot measures. As always, we will be making information available on our local website alameda.ca.lwvnet.org and on smartvoter.org.

Much activity means much work to be done. Our plans include expanding our Voter Service Committee, and we invite you to consider joining, choosing tasks you'd like to work on. Please contact Joanne McKray at 522-6760 to talk about it!


